Minutes of a meeting of the Parish Council held at Cressage Village Hall on Tuesday 9th September 2025 at 7pm

51.25 Chairman's welcome

The Chairman welcomed everyone to the meeting and said it was nice to see so many people in attendance.

52.25 To note Apologies

Apologies were received from Cllrs Roger Beardsmore and Matt Murray.

An apology from Cllr Shaun Bott was sent before the meeting.

53.25 To note Declarations of Pecuniary Interest or consider dispensation requests

There were no declarations of Pecuniary Interest or dispensation requests at this time.

54.25 Public session

Residents present at the meeting raised concerns about the planning application to put 60 dwellings at the west of Harley Road. Comments of concern included the density of the proposed housing on the site, and the impact on village life, particularly infrastructure. The school is overproscribed, and it is difficult already to get a doctor's appointment. A resident raised the lack of amelioration in the plans. There is nothing to show access for pedestrians across a very busy road (the A458). There is no inclusion of walkways. Another resident commented that it had taken her ten minutes to safely cross the road to look at the notice placed next to the site entrance. It was commented that the speed survey as included in the plans was a farce. The suitability of the land for this amount of housing was questioned, including noting that with the collapse of the Local Plan this is now open countryside. The stability of land at the entrance and exit to the site was suggested has having been an unresolved issue.

The Parish Clerk said she had received two written enquiries prior to the meeting:

A resident had reported a day burning streetlight outside 39 Severn Way. This is under the responsibility of the Parish Council. It was agreed that the Parish Clerk should follow this up with the maintenance company (Prysmian).

A resident of Cressage has asked if the Parish Council would ever consider adding a tarmac path around the perimeter of the recreation field to make the space more accessible to pushchairs, wheelchairs and children on scooters, and to facilitate runners.

55.25 Shropshire Councillor's Report

Cllr Susan Coleman noted that there had been land development sites call out and a new Local Plan is being written as the current Local Plan is defunct. The development sites are not just for houses. There Council is under pressure to build extra houses as the Government has doubled housing targets.

Cllr Coleman reported on the development of a bio-char plant outside Ludlow. The significance of this is financial, as it will create extra revenue. There will be a meeting of the cabinet to discuss the dire state of the finances. More positive news is that the Children's Service has been rated Outstanding in an Ofsted report. Holiday activities including a food programme will continue over the next 3 years.

Cllr Dan Thomas reported that the 3-18 Education Trust has submitted a new application for Much Wenlock Leisure Centre. The previous application was for half CiL half from Shropshire Council's budget, but the overspend at Shropshire Council means this will not be possible. Meanwhile, the future of Cleobury Mortimer's Leisure Centre has not been secured.

Cllr Thomas will be holding an advice surgery on Saturday 13th September at Much Wenlock Museum (10.30am to midday). There will be a police representative.

The Parish Council considers that it needs to see more detailed plans to enable any informed decision.
